Order:

Pursuant to section 49(1)(d) of the *Oil and Gas Activities Act* (the Act), I, Patrick Smook, order that Canadian Natural Resources Limited (CNRL) must:

1. For each well listed on the attached Schedule A that has been suspended in accordance with section 25(5) of the Drilling and Production Regulation (DPR), submit a well suspension report to the Oil and Gas Commission (Commission) via the eSubmission portal by November 30, 2018.
2. For each well listed on the attached Schedule A that has not been suspended in accordance with section 25(5) of the DPR, suspend, reactivate or abandon the well by April 30, 2019.
3. For each well suspended as required under item 2, submit a well suspension report to the Commission via the eSubmission portal within 30 days of the suspension.

Conditions:

- A. This order shall remain in effect until amended or terminated in whole or in part by the Commission.

Reasons:

I make this Order for the following reasons:

- i. CNRL is the permit holder of each of the wells listed in the attached Schedule A.
- ii. On February 27, 2018 and April 11, 2018, CNRL submitted to the Commission timelines and plans to suspend, reactivate or abandon the inactive wells on the attached Schedule A. To date CNRL has failed to complete the work within the submitted timelines.

- iii. Section 25(5) of the DPR requires a well permit holder of an inactive well to suspend the well in a manner that ensures the ongoing integrity of the well, within 60 days of the well becoming inactive.
- iv. Section 25(3) of the DPR requires a well permit holder of an inactive well to submit a report to the Commission within 30 days of the suspension of a well.
- v. A search of Commission records indicates that CNRL has not submitted suspension reports for the wells listed on the attached Schedule A as required under section 25(3) of the DPR.
- vi. I am of the opinion that CNRL is not in compliance with section 25 of the DPR.

Review and Appeal:

CNRL may request a review of this order under section 70 of the Act by submitting a request for review to ogc.determinationreviews@bcogc.ca.

CNRL may appeal this order to the Oil and Gas Appeal Tribunal under section 72 of the Act. The process for appeals may be found at www.ogat.gov.bc.ca and a notice of appeal may be sent to the Oil and Gas Appeal Tribunal at:
