
**RE: APPLICATION FOR SALT WATER DISPOSAL



IN THE MATTER of a scheme of Quintana Exploration Canada Ltd. for Salt Water Disposal (SWD) in either the Cadomin, Nikanassin or Halfway Formation in the well Quintana et al Monias 6-26-83-21 W6M.

The Ministry of Energy, Mines and Petroleum Resources (ministry), pursuant to section 116 of the Petroleum and Natural Gas Act, hereby orders as follows:

1. The SWD scheme of Quintana Exploration Canada Ltd. (Operator) for disposal of produced water into either the Cadomin, Nikanassin or Halfway Formation at well 6-26-83-21 W6M as such scheme is described in the application from the Operator to the ministry, is hereby approved, subject to the terms and conditions herein contained.
2. The water disposal interval must be in either the Cadomin, Nikanassin or Halfway Formation.
3. A record of volumes disposed of through this well should be included on a Monthly Injection/Disposal Statement. The statement should be submitted not later than the 25th day of the month following the reported period.
4. The approval may be modified or rescinded at a later date if deemed appropriate through a change in circumstances.
