THE PROVINCE OF BRITISH COLUMBIA <u>PETROLEUM AND NATURAL GAS ACT</u> MINISTRY OF ENERGY, MINES AND PETROLEUM RESOURCES ENERGY RESOURCES DIVISION

IN THE MATTER of a Concurrent Production scheme of Canadian Natural Resources Limited (CNRL) for producing the Buick Creek Lower Halfway "H" Pool with a project oil and gas allowable.

NOW, THEREFORE, the Division Head, pursuant to section 113 of the *Petroleum and Natural Gas Act*, hereby approves the Concurrent Production scheme of CNRL for concurrent oil and gas production with project allowables, as such scheme is described in

an Application from CNRL to the Division dated August 14, 1995, and related submission.

This scheme is approved, subject to the conditions herein contained and, in particular:

- 1. The area of the scheme shall consist of unit 45 of Block A/94-A-14.
- 2. The project oil allowable is 32.3 m³/d.
- 3. Gas production from the project will be limited to 35 10³m³/d.

- 4. All associated gas production will be conserved.
- 5. The scheme shall be deemed to have commenced upon the conservation of gas referred to in clause 4, with the ministry being notified in writing of the date of commencement.
- 6. Royalty free oil production from the discovery well c-45-A/94-A-14 (WA 9204) is limited to a total volume of 10792.6 m³, or the volume produced in the first 36 producing months, whichever is lesser.

7. This approval may be modified or rescinded at a later date if deemed appropriate.
