This refers to your application dated November 27, 1991, wherein a Good Engineering Practice (GEP) approval was requested for the Montney Halfway "D" and "H" oil pools.

We concur with your analysis regarding the geological mapping of the Montney Halfway "D" and "H" pools as well as the existing commingling of production in these pools. There are no equity concerns as the land covering these pools is controlled by Poco. ## THE PROVINCE OF BRITISH COLUMBIA PETROLEUM AND NATURAL GAS ACT DRILLING AND PRODUCTION REGULATION MINISTRY OF ENERGY, MINES AND PETROLEUM RESOURCES ENERGY RESOURCES DIVISION

IN THE MATTER of a Good Engineering Practice (GEP) scheme of Poco Petroleums Ltd. (Poco) for producing Montney Halfway "D" and "H" Pool oil wells with a project oil allowable.

Now therefore the Division Head, pursuant to Part 8, Division 6, section 104 of the Drilling and Production Regulation, hereby approves the GEP scheme of Poco for oil production with a project oil allowable being the sum of individual well allowables, as such scheme is described in

(a) Application from Poco to the Division dated 27th November 1991 and related submission.

This scheme is approved, subject to the conditions herein contained and, in particular:

- 1. The area of the project shall consist of Section 1-87-19 W6.
- The project oil allowable, being the sum of individual well allowables, is 61.7 m<sup>3</sup>/d.
- 3. Associated gas production of the wells will continue to be conserved.
