RE: : APPLICATION TO AMEND PRESSURE MAINTENANCE APPROVAL BRASSEY ARTEX "A", "B", "D" AND "G" POOLS

The Commission acknowledges receipt of your application dated June 13, 2000 requesting that the pressure maintenance approval be amended to allow gas sales from the Brassey Artex "B", "D" and "G" pools.

Reference is made to the Ministry of Employment and Investment letter of December 10, 1997 wherein approval was granted to allow lowering of average reservoir pressures in the Brassey Artex "B", "D" and "G" pools. Consequently, condition #2 of the pressure maintenance scheme by gas reinjection granted under section 116 (now section 100) of the Petroleum and Natural Gas Act on June 29, 1989, subsequently amended on April 6, 1990, February 20, 1991, September 2, 1993, February 8, 1994, December 10, 1997, July 29, 1998 and May 10, 2000 is hereby amended as follows:

2. Produced gas may be injected into the following wells:

Pool "A": d-89-B/93-P-10

Pool "B": d-13-F, c-34-F, d-44-F and d-55-F in 93-P-10 and 13-1-77-19 W6M.

Pool "D": d-A71-C and a-82-C in 93-P-10.

Pool "G": d-93-C/93-P-10

Please note that as per condition # 6 of the approval, the average reservoir pressure in Pool "B" must be maintained above 22,000 kPa and above 20,000 kPa in Pools "D" and "G".

All other conditions of the approvals remain unchanged.
