Top Three Actions Taken Towards Carbon Neutrality in 2016

1. Five per cent reduction in vehicle fleet fuel consumption between 2015 and 2016.

- Total fuel use – 6,798 litres.
- Forty-five per cent reduction in diesel consumption – attributed to fewer trips between the Core Research Facility and Charlie Lake storage facility, with more core samples being housed in the research facility and more efficient processes for retrieval from storage.

2. The Commission intended to replace three vehicles with more fuel-efficient units in 2016, but delivery will not occur until the 2017 calendar year. The Commission has been able to order four replacements and the benefits will be reflected in next year's report.

3. Continued to utilize the FOB Authentication, Printer Defaults set to duplex and black and white printing, and RightFax system to reduce both paper and printer use, however the significant reduction is also likely attributed to the implementation of the Application Management System (AMS) as applications and permits are now mostly received and produced electronically.

- Paper use between 2015 and 2016 was reduced by 43 per cent
This percentage reflects 825 packages of paper
- Copies printed between 2015 and 2016 was reduced by 18 per cent
This percentage reflects 225,369 paper copies



2016 Greenhouse Gas Emissions

The Commission emitted 422 tonnes of carbon dioxide equivalent (CO₂e) from sources covered under the Carbon Neutral Government Regulation (CNGR) in the 2016 calendar year.

Offsets Applied to Become Carbon Neutral in 2016

The Commission has purchased 413 tonnes of offsets to achieve carbon neutrality, as required by the CNGR using the web-based reporting system SMARTTool.

Future Plans for Emissions Reduction Activities

The Commission will replace five vehicles with more fuel efficient units in 2017. Additionally, the Commission will continue to utilize the FOB authentication and RightFax system to reduce GHGs as outlined in the core actions taken in 2016. The Commission's Corporate Property and Administration team will also revise both the Pooled Vehicle Procedures and the Assigned Vehicle Procedures, reflecting a change in the use of fleet vehicles for long-distance travel. It will ensure the operator must choose the most economical option (flying vs driving).
