IN THE MATTER of a scheme of Suncor Inc. for Salt Water Disposal (SWD) in the Dunlevy Formation in the well Suncor et al Lagarde 8-29-87-15 W6M.

The Ministry of Energy, Mines and Petroleum Resources, pursuant to section 116 of the <u>Petroleum and Natural Gas Act</u>, hereby orders as follows:

- 1. The SWD scheme of Suncor Inc. (Operator) for disposal of produced water into the Dunlevy Formation at well 8-29-87-15 W6M as such scheme is described in the application from the Operator to the Ministry dated August 14, 1992, is hereby approved, subject to the terms and conditions herein contained.
- Water disposal interval must be in the Dunlevy Formation (1111-1113 mKB).
- 3. A record of volumes disposed of through this well should be included on a Monthly Injection/Disposal Statement. The statement should be submitted to the Victoria office not later than the 25th day of the month following the reported month.
- 4. The approval may be modified or rescinded at a later date if deemed appropriate through a change in circumstances.
