### INSTRUCTIONS

1. Submit a separate Statement for each Agreement/Assignment. Multiple years of unpaid rent on a single Agreement/Assignment may be applied for in one Statement.
2. Examples of an oil and gas activity, as required in paragraph 2 (a) or (b) include, but are not limited to, a well site, facility, pipeline, and oil and gas road.
3. A witness must be 19 years of age or older and cannot be a land owner named in the Statement, or spouse or other family member of a land owner named in the Statement.
4. Attach a complete copy of the Agreement/Assignment to this Statement and mark the first page as Exhibit "A".
5. Attach complete copies of any documents that support this claim for compensation [for example, rent renewal statement(s), cheque stub(s), bank statement(s), and/or any agreement(s) with respect to rent renegotiation] and mark the first page as Exhibit "B".
