Producing pools not listed in the table below require **annual** pressure surveys. Disposal wells **are not exempt** from annual pressure surveys.

It is the responsibility of the individual well operator to ensure that the minimum testing requirements are met. Any pressure tests conducted in addition to the minimum required must still be submitted to the Commission. Initial pressure tests must be conducted on all new wells drilled, regardless of annual pressure survey requirements. Initial pressure tests can be used towards satisfying the annual testing requirements.
