

IN THE MATTER of a scheme of Berkley Petroleum Corp. (Berkley) for Salt Water Disposal (SWD) in the Baldonnel formation in the well Berkley et al W Blueberry a-7-L/94-A-12 (WA# 2435).

NOW, THEREFORE, pursuant to Part 8, Division 3, Section 94 of the *Drilling and Production Regulation*, the SWD scheme is hereby approved, as such scheme is described in

an application from Berkley to the Commission dated March 17, 1999.

1. The water disposal interval must be in the Baldonnel formation.
2. A record of volume of salt water disposed of through this well must be included on a Monthly Injection/Disposal Statement, in the prescribed form (BC-S18), which must be submitted to the Oil and Gas Commission not later than the 25th day of the month following the reported month.
3. The disposal/injection pressure at the sandface must not exceed the formation fracture pressure.
4. This approval may be modified or rescinded if deemed appropriate through a change in circumstances.
