


APPROVAL 92-09-001 (AMENDMENT #1)

THE PROVINCE OF BRITISH COLUMBIA

ENERGY RESOURCES DIVISION

IN THE MATTER of a pressure maintenance scheme amendment of Morrison Petroleum Ltd. (Morrison) for waterflood recovery of oil by water injection into the Beatton River Halfway "G" Pool.

The Minister of Energy, Mines and Petroleum Resources, pursuant to section 116 of the *Petroleum and Natural Gas Act*, hereby orders as follows:

1. The pressure maintenance scheme of Morrison for waterflood recovery of oil from the Beatton River Halfway "G" Pool as such scheme is described in the Application from Morrison to the Ministry dated February 9, 1995, is hereby amended, subject to the terms herein contained.
2. The pressure maintenance scheme area shall be delineated by units 14, 23, 24, 33 and 34 Block K/94-H-2.
3. The project oil allowable is 200 m³/d.
4. Water will be injected into the Beatton River Halfway "G" Pool through well d-14-K/94-H-2.
5. An oil well may be drilled anywhere within the project area provided that it is not nearer than 100m to the sides of the approved area.
6. Reservoir pressure must be maintained above 6400 Kpaa.
7. This approval may be modified or rescinded at a later date if deemed appropriate.
