RE: INTERIM COMMINGLED PRODUCTION APPROVALS BEG AND JEDNEY FIELDS

The Oil and Gas Commission has reviewed your letter dated June 13, 2000, requesting approval to commingle gas production from the Baldonnel and Halfway zones at four proposed well locations. We understand that prior approval is sought in order to finalize drilling and completion programs, specifically, required casing sizes.

The proposed subject well locations are as follows;

a-54-F/94-G-1 (BH c-53-F)
Beg — Baldonnel "B" & Halfway "A"

a-85-F/94-G-1 (BH b-74-F)
Beg — Baldonnel "B" & Halfway "A"

a-85-F/94-G-1 (BH c-85-F)
Beg — Baldonnel "B" & Halfway "A"

a-55-J/94-G-1 (BH a-55-J)
Jedney — Baldonnel/Upper Charlie lake "A" & Halfway "A"

As noted in your application, the OGC has previously approved commingled production from these same fields and pools for a number of wells, in order to increase recoveries. The proposed locations are all within approved gas GEP areas.

We wish to advise you that your application to commingle production from these pools is hereby granted interim approval, under the authority of section 41 of the *Drilling and Production Regulation*, subject to the following conditions:

- 1. A production test must be completed on each zone prior to commingling, gathering sufficient data to establish the AOF and reservoir pressure. Reports must be filed as per the requirements of sections 84 and 95 of the *Regulation*.
- 2. A formal application for commingled production, with supporting log and test date must be submitted, with proposed allocation factors for production reporting.
- 3. This approval may be modified at a later date if deemed appropriate through a change in circumstances.
